- A Booth Fee of **\$140. For current Members of YAA (10'X 10' booth space).**
- A Booth Fee of **\$160. For non-members of YAA (10'X 10' booth space).**
- Entry Fees are non-refundable and must be enclosed with each application.
- Make **checks** payable to: **York Art Association**; PO Box 74; York, ME 03909
- Credit card payments; www.yorkartassociation.com (mastercard & visa)
- All applications must be postmarked by **May 15, 2018.**
- Spaces are assigned on a first come, first serve basis.
- A specific space request must be made on your application and if available, an effort will be made to assign it to you.
- Extra footage necessary, \$15. per foot. Please include with Entry Fees. Indicate necessity within the **COMMENTS** section of the application.

Additional Requirements for New Artists

- There is an additional \$15 non-refundable jury fee for all new artists.
- All new artists must submit three images of recent work along with jury fee.
- Deadline for new artist submission, **May 1, 2018.**
- Images maybe photos or jpg images (provided on disc or USB stick). Each image must include **ARTIST NAME, MEDIUM, SIZE and TITLE OF PIECE.**
- Please provide a #10 self-addressed stamped envelope if you wish your photos to be returned.
- Acceptance or rejection notice will be mailed out within 4 week of receipt.
- **Please do not email jpg images.**
